#### **Our Mission**

The Center for Intelligence and Crime Analysis (CICA) in the College of Criminal Justice at Sam Houston State University develops and delivers professional development courses for working analysts, fosters academic opportunities for SHSU students, and provides technical assistance to public safety organizations, including police, corrections, and prosecutors offices.

CICA leverages SHSU expertise by involving faculty and students in instruction and in providing technical assistance to organizations. Professional development courses use RMS police data from the CRIMES program designed and operated by the College of Criminal Justice. This provides a unique opportunity for class participants to learn with real-world data.

#### What We Offer

The Crime Analysis Certificate (CAC) program is a four-course series that prepares both new and experienced crime analysts to excel in their professional roles through 128 hours of instruction from expert practitioners and academics across the crime analysis field.

#### **Crime Analysis Certificate**

- 1. Foundations of Crime Analysis
- 2. Databases and Analysis
- 3. Social Network Analysis
- 4. Crime and Problem Mapping

Complementing the CAC program are specialized professional development courses that offer advanced training opportunities and focus on specific topics and skills. Participants can earn TCOLE credits upon course completion.




## **Crime Analysis Certificate**

#### **Progress Overview**

CICA staff continue to leverage existing partnerships with our professional network of analysts, including criminal justice and public safety agencies. These partnerships have garnered a significant increase in awareness of and interest in CICA's offerings, specifically the Crime Analysis Certificate program.

#### **CAC** Assessment

In the coming months, CICA staff plans to launch an extended follow-up survey to evaluate the lasting impact the program has had on certificate recipients and their work. This feedback and reflection will allow CICA staff to adjust the program's curriculum and address learning gaps that may not arise until six months to a year post-completion.

#### **Progress Overview**

CICA staff continue to work with practitioners and stakeholders to identify training needs and rapidly develop courses that address gaps and meet needs within the crime analysis field. These stakeholders represent distinct yet overlapping areas of public safety, including port security, healthcare security, and criminal justice system agencies.

#### **Goals for Special Topic Courses**

In the coming months, CICA staff plans to launch a new special topic course to equip healthcare security professionals and leaders with actionable information that can be used to build and enhance threat management units and functions. Additionally, CICA staff is working with external partners to develop a new course that will dive deeper into the full potential of crime analyst positions and enhance organizational capacity.

#### **Academic Programs**

CICA staff collaborated with faculty in the Department of Criminal Justice and Criminology and the Department of Environmental and Geosciences at SHSU to create a minor and certificate in Crime Analysis and Mapping. The minor and certificate became available to SHSU undergraduate students in the fall 2023 semester. Two undergraduate SHSU students successfully completed crime analysis internships with the Crime Analysis and Intelligence Division in the Harris County Sheriff's Office in 2023. Two SHSU students will have crime analysis internships in spring 2024 with the SHSU University Police Department.
