
## ***IHS to present at the 2026 Academy of Criminal Justice Sciences Annual Meeting***

## Cybersecurity Training Effectiveness in Texas Rural Hospitals for Texas Hospital Association

Cybersecurity threats continue to escalate across the healthcare sector, placing rural hospitals in Texas at particularly high risk.


Cybersecurity threats are rapidly escalating across the healthcare sector, placing rural hospitals in Texas at heightened risk due to increasing ransomware, phishing, and data breach incidents that strain already limited operational and financial resources. Recent high-profile attacks have led to system downtimes, disrupted patient care, and elevated risks to patient safety and data privacy, with small, resource-constrained hospitals disproportionately targeted because of aging technology, limited budgets, and shortages of specialized cybersecurity staff. In response, Texas mandates annual cybersecurity training for hospital staff under Department of Information Resources (DIR) guidelines. This report synthesizes regulatory requirements, academic literature, and national best practices to evaluate the effectiveness and limitations of current cybersecurity training in rural hospitals, examining factors such as training frequency, delivery methods, tenure-based disparities, departmental involvement, review cycles, perceived policy effectiveness, and feedback mechanisms, and concludes with actionable recommendations tailored to the unique needs of rural Texas healthcare facilities.
